

DATA FOR PROGRESS

From November 19 to 22, 2021, Data for Progress conducted a survey of 1,241 likely voters nationally using web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, and voting history. The survey was conducted in English. The margin of error is ± 3 percentage points.

NB: subgroups with a n-size less than 50 (<50) are not shown on these cross-tabs. We choose not to display N<50 subgroups because the sample is too small to have statistical significance. We did, however, take samples of these subgroups for representational and weighting purposes to accurately reflect the electorate makeup. Some values may not add up to 100 due to rounding.

[2] The Supreme Court is currently deciding to uphold or strike down a New York state gun control law that allows the state to set stricter gun laws in urban areas than they do in rural areas.

Supporters of the law argue that not regulating concealed carry laws in highly populated urban areas increases the chance of gun violence and makes police work more difficult.

Opponents of the law argue that it is an infringement on the Second Amendment right to keep and bear arms.
