The sample was weighted to be representative of likely voters by age, gender, education, race, and voting history. The survey was conducted in English. The margin of error is ±3 percentage points.

[2] A conservatorship, also called a guardianship, is when a court appoints a third party to manage the financial affairs and/or personal affairs of another adult because of the individual's disability cognitive limitations. or Conservatorships and guardianships can limit the rights people have to direct their own lives, make choices about reproductive health, decide what medical or psychiatric care they want, decide how the money they earn is spent, and even whether they can vote or get married. It can be relatively easy to get a guardian appointed and is often difficult to get a guardianship or conservatorship terminated.

She spoke about being forced to give her father huge sums of her earnings, being prevented from spending her own money herself, being forced to perform when she was sick, being drugged against her will, and not being allowed to remove a birth control device preventing her from having children. Spears stated that she wants her conservatorship to end, and had not been informed by her attorney that she could petition for the court to end it.

With supported decision-making, the individual chooses people they trust to be part of a support network to help them with decision-making.
