From June 20 to 25, 2024, Data for Progress conducted a survey of 1,234 U.S. adults nationally using web panel respondents. The sample was weighted to be representative of U.S. adults by age, gender, education, race, geography, and 2020 recalled vote. The survey was conducted in English. The margin of error associated with the sample size is ±3 percentage points. Results for subgroups of the sample are subject to increased margins of error.
