From August 16 to 18, 2024, Data for Progress conducted a survey of 1,239 U.S. likely voters nationally using web panel respondents. The sample was weighted to be representative of likely voters by age, gender, education, race, geography, and 2020 recalled vote. The survey was conducted in English. The margin of error associated with the sample size is ±3 percentage points. Results for subgroups of the sample are subject to increased margins of error. Partisanship reflected in tabulations is based on self-identified party affiliation, not partisan registration. For more information please visit dataforprogress.org/our-methodology.

Data for Progress conducted message testing through maximum difference scaling (MaxDiff) to determine the ordinal ranking of 12 messages on home and community based services. Respondents were shown a randomized subset of 4 of the messages, and asked to pick the most and least convincing message from those options. They were then asked to do the same across multiple rounds, each time with a new set of 4 randomized messages.

Using these responses, we project what percentage of likely voters would select each message as the most convincing and what percentage of likely voters would select each message as the least convincing from the full set of messages. The scores below represent net convincingness of each message — meaning, the projected percentage of likely voters viewing a certain message as the most convincing, minus the projected percentage viewing it as the least convincing.

NB: subgroups with a n-size less than 50 (<50) are not shown on these cross-tabs. We choose not to display N<50 subgroups because the sample is too small to have statistical significance. We did, however, take samples of these subgroups for representational and weighting purposes to accurately reflect the electorate makeup. Some values may not add up to 100 due to rounding.
